Middlesex Law Society launches our 'Continuing Competence' Program

As you are no doubt aware the SRA have changed the way in which continuing training of solicitors can be conducted from the 1st November 2016. From April 2015 firms have been able to plan their own training programs under the scheme known as 'Continuing Competence'

The requirement for 16 hours CPD is no longer the case and as of 1st November 2016 firms will be required to develop their own programs of training relevant to the requirements for staff at each firm.

To launch this year's MLS education program and to allow those of you who need to catch up their CPD quota for this year, MLS in association with Audit Compliance Ltd, Middlesex University Law School and Ealing Law School at University of West London have developed the following program.
